Report of the Headmaster: Kirby McCrary presented the Headmaster's Report emphasizing the following items:

- 1. To help with the increased number of negatively impacted families, the school's online, lunch-ordering system now allows for families to contribute school meals to those in need. Beginning with the December lunch menu, families can **donate lunches** for families that qualify for free or reduced lunches. Every penny donated goes directly to a meal for someone in need.
- 2. Lower School Director Michael Reeves, Upper School Director Jarrid Looney, Director of Development, Lu Ann Browne, and Headmaster Kirby McCrary met to discuss marketing, specifically how to paint a picture for the broader community of what the school offers and how that ties directly to their often unspoken hopes and dreams. Specific ideas included highlighting MCA's concept of citizenship, profiling teachers as they talk about math, Core Knowledge, learning to read, etc., interviewing graduates, and publishing aspects of the curriculum, such as lists of books, topics, and perennial questions. This group will reconvene to map out a plan.
- 3. Lower School Director Michael Reeves, Upper School Director Jarrid Looney, Director of Development, Lu Ann Browne, and Headmaster Kirby McCrary met to discuss how to use the school's facility to the advantage of the community now and in the distant future. This group will reconvene to further develop ideas.
