MILLENNIUM CHARTER ACADEMY BOARD OF DIRECTORS MEETING MINUTES February 22th, 2022

The Board of Directors for Millennium Charter Academy met in regular session on Tuesday, February 22th, 2022 at 5:30 pm. Those Directors present included Renee Francis (remote) Christopher Willingham (remote), Mark Hampton (remote), Beth Southern (remote), Druery Devore, Ann Jones (remote), and Marty Danley (remote). Headmaster Kirby McCrary and Finance Officer Patty Bare were also present for the meeting. Renee Francis called the meeting to order with Kirby McCrary providing the Invocation. Renee Francis led the Board in the Pledge of Allegiance.

Directors Susan Campbell and Carla Majure were not present for the meeting.

Adoption of Proposed Agenda: Upon the motion of Christopher Willingham, seconded by Beth Southern, the proposed agenda was adopted.

Approval of Minutes: Upon the motion of Christopher Willingham, seconded by Mark Hampton the January 5th and January 25th minutes were approved

Report of Affiliated Organizations: None

Report of the Headmaster: Kirby McCrary presented the Headmaster's Report emphasizing the following items:

- Recent test scores indicate the quality of MCA's classical education. MCA does not teach to the test nor does the school
 hyper-focus on standardized test scores, and regardless of COVID, gender, race, disability, or economic situations, MCA
 students outperform local and public school statewide.
 - a. In the fall of this school year, DPI released **proficiency scores**. These scores indicated that MCA students performed better than the state averages or local school averages in 6th -8th grade reading, 6th 8th grade mathematics (except local 7th grade scores), 8th grade science, English II, Algebra I, Algebra II, and biology.
 - b. According to DPI's January release of **growth scores**, students who come to MCA continue to climb academically. Upper school students met or exceeded the state's growth expectations in all tested areas (Reading 6-8, Mathematics 6-8, Science 8, Algebra I, Algebra II, English II, and Biology). Students in fifth grade also met or exceeded growth expectations in reading, math, and science. Furthermore, in all of the subgroups, the upper school students met or exceeded growth on all tests. (The Office of Development will feature this information in an upcoming publication.)
- 2. Outside of state administered benefits (health and retirement), two companies, Admin Partners and Prudential, provide MCA's **benefit packages**. Admin Partners has a 403(b) and recently added a 457. Prudential carries a 401(k) and a 457.
- 3. Charter Schools Capital Marketing Update.
- 4. Promotion of **MCA's football program** continues to move forward. Mrs. Delp (current parent and unofficial leader), Mr. Resignalo (current parent and arena league football coach), Mr. Cardwell (current parent and former NFL player), and Mr. Robertson (former parent), along with Mr. Mitchell (faculty member) and Mr. McCrary met with the sixtheighth graders to explain the possibilities and to promote the free football clinic to be offered in March, not only for MCA students, but also for the entire community. Athletic director Rodney King and some of the aforementioned will meet with interested parents within a couple of weeks.
