## Report of Affiliated Organizations: None

**Report of the Headmaster:** Kirby McCrary presented the Headmaster's Report emphasizing the following items:

- 1. Ms. Lissa Carter has decided to retire on July 31 of this year.
- 2. Mandy Tucker, Scarlett Hiatt, and Matthew Martina, long-time MCA parents and school supporters, met with Coach King and Mr. McCrary about their willingness and preliminary plans to help construct a baseball field.
- 3. MCA's football program continues to move forward. MCA parents Tammy Delp and Joshua Resignalo, and MCA's athletic director Rodney King hosted a successful informational meeting for parents. Later, on March 12 MCA parents Tammy Delp and Joshua Resignalo, along with Ethan Farmer and Adam Smith of the Carolina Cobras arena football team, Chris Robertson, owner of Primetime Fitness and former MCA parent, Michael Mitchell, MCA's new director of IT (who will be working with the defense) hosted a free football clinic at Primetime Performance in Mount Airy. Approximately fifty students participated.
- 4. Athletic director Rodney King hosted a meeting with about ten parents who have recently expressed interest in furthering MCA sports, and in particular the development of the sports complex on Riverside Drive. That group is now a working committee reporting to and guided by Coach King. Directors Christopher Willingham, Carla Majure, and Druery Devore will participate on the committee. Druery Devore will provide updates to the Board.
- 5. MCA's first Poetry Aloud competition went virtual two years ago when COVID-19 struck. This year, the competition promises to be a grand celebration not only of poetry but of the arts in general. Beginning in January with classrooms selecting poetry to memorize and to say aloud, the students have already competed for division titles, and on March 30, the division winners will compete for the K-12 title.

- 3. Upon the motion of Christopher Willingham, seconded by Druery Devore, it was approved to evaluate the current faculty-to-student ratio and make adjustments necessary to right-size.
