**Report of the Headmaster:** Kirby McCrary presented the Headmaster's Report emphasizing the following items:

- Kirby McCrary presented several candidates for hire. The first of which was Schmidty
  Crossingham for the position of fifth and sixth grade science teacher. Our policy of familial
  relationships was disclosed and discussed prior to the vote. James Crossingham recused
  himself from the vote and will do so for any future teacher budgetary related items. Upon the
  motion of Susan Campbell, seconded by Christopher Willingham, the board voted to offer Ms
  Crossingham a teaching position.
- 2. Additional candidates: Casey Elrod as a second-grade teacher, Donald Lanter for upper school Spanish teacher, Nicholas Roman to serve as physical education teacher, RaChael Holler as an upper school English teacher. All were approved by the board upon a motion by Christopher Willingham, seconded by James Crossingham. We are pleased to welcome the candidates into our MCA family.
- 3. Rodney King, who has been instrumental in establishing MCA's sports program and conferences, resigned effective May 31. We wish him well.
- 4. I am excited to say that Nicole Ashburn, MCA mom, head volleyball coach, and employee, has enthusiastically agreed to be MCA's athletic director. She has already proven herself to be a capable leader devoted to this school and to MCA athletics. Coach King will work with her to make a smooth transition
- 5. MCA named Mike Russell as the new head coach of the boys' varsity basketball team. Coach Russell is currently head skills developer for CP3 Basketball Academy, where he has been the past five years. Coach Russell will be sharing information about summer camps soon.

**Report of the Treasurer:** Christopher Willingham presented a Treasurer and Finance Committee report.
